MEMORANDUM

In pursuance to the Executive Director (Pers.), Vidyut Bhawan, Shimla-4 letter No. HPSEBL (SECTT)/HRD./2-12(R/MENT)/2019-87638-788 dated 11.02.2019 Mr./Mrs. Amir Chand S/O Sh. Bhagwan Singh (Ref. No. ST.4729) is hereby offered appointment as Junior T/Mate (Class-IV) post in the share of ST(UR) Category purely on contract basis in HPSEBL in the Pay Band -AI CPB-4900-10680+1300 Grade Pay +an amount equal to +100% Grade pay with fixed Contractual Emoluments of Rs.7500/- per month strictly as per R&P rules and in accordance with model roster notified by the H.P. Govt. and adopted by HPSEBL on the following terms & conditions.

1. He/She will be paid consolidated monthly emoluments @ Rs.7500/- (indicate basis pay of initial pay scale of the post) i.e. Rs. 4900+1300GP+ an amount equal to 100% of GP. He/She shall not be entitled for any other allowance whatsoever to the employee of the State Govt. /Board from time to time.
2. The appointment shall be purely on contractual basis for a period of one year from the date of joining the post.
3. His/her age should be between 18 to 30 years as on 01.01.2018 .Upper age limit is relaxable by five years for candidates belonging to Scheduled caste. Scheduled Tribe and other Backward Classes and Children/Grand Children of Freedom Fighters of Himachal Pradesh. The upper age relaxation is also available to Ex-servicemen candidates of H.P as per provision of relevant rules/instruction of H.P. Govt.
4. His/her appointment will be subject to the production of medical certificate of fitness from the Chief Medical Officer of the Govt. Hospital.
5. The appointment shall further be subject to terms & conditions of attached ~~from~~ contract/agreement bond (Annexure-"B") which is to be executed between the candidate and HPSEBL (Appointing Authority) on stamp paper valuing Rs. 5/- only duly attested.
6. He /She should give a declaration that he/She got one living wife/husband or is bachelor.
7. He/She is required to produce antecedent verification certificate to the satisfaction of the department from the Ist class Magistrate or two gazetted Officers known to him atleast from the last three years.

He/She is required to produce all original certificate viz. qualification certificate/Technical qualification certificate/Himachali Bonafide certificate /Scheduled castes certificate/Scheduled Tribe certificate (in case of scheduled Caste/Tribe candidate) etc. in support of his/her qualification, age and if he/she belongs to any reserved class and identity proof i.e. Adhar card etc. at the time of joining to the post.

9. He/She will be required to take oath /affirm on the following form.
