


2. He/ She required producing his/her original qualification certificate to the concerned officer before joining the post in proof of his/ her qualification and age (where applicable).
3. He/ She required to produce original certificate from the competent authority to the effect that he/she belong to the Scheduled caste/Scheduled Tribe/ Backward Class/ Physically handicapped/ Ex-serviceman/ IRDP/ Non employment certificate to the officer concerned before joining the post, if he/she belongs to such category.
4. The appointment shall further be subject to terms & conditions of attached form of contract/ agreement bond (Annexure-I) annexed herein which is to be executed between the candidate and the HPSEB Ltd., (Appointing Authority) on stamp paper valuing Rs. 5/- only duly attested.
5. He/She will be liable to be transferred in the exigencies of HPSEB Ltd., interest, wherever the posts are available and where the HPSEB Ltd, has its units/organizations.
6. He/She should give a declaration that he/she has got only one living spouse or is an unmarried.
7. He/She will furnish declaration in writing that he/ she has not been dismissed from any institution/ organization under the Government of India.
8. He/She is required to produce all original certificates viz non-employment certificate in the name of deceased wife/qualification certificates/Himachali Bonafide certificates, SC/ST/OBC etc. in support of his/her qualification, age and belonging to any reserved class at the time of joining the post.
9. He/ She will have to take an oath and undertaking in writing that he/ She will not leak official information and shall be subject to official secrets.
10. He/She will have to produce a Medical Certificate of fitness duly signed by an authorized Chief Medical Officer/ Medical Officer of the Govt. indicating that he/she is not suffering from any communicable disease.
11. He/ She will have to produce a Character Certificate from Magistrate Ist Class or a Gazetted Officer known to his/her for the last three years before he/she joins the post.
12. His/ her seniority in the Grade will be fixed later-on in accordance with the relevant rules/instructions.
13. He/She will be required to take an oath/affirm that I will be faithful and bear true allegiance to the Constitution of India as by law established and that I shall carry out my office duties with loyalty, honesty and with impartiality.


