TERMS AND CONDITIONS


1. The appointment initially shall be purely on contractual basis for one year which contract could be extended further depending upon requirement of the services of such appointee and recommendation by H.O. office about his/her performance, requirement of work and conduct on the job. However, his/her services may be terminated even prior to the completion

of contract period by issuing of one month notice or payment of one month wages in lieu of the notice, if his/her services are not required due to non availability of work, for which principle of first come last go shall be followed. His/her services may also be terminated during the contract period if his/her conduct and performance is not found satisfactory for which notice with due opportunity of being heard shall be given.

2. His/ Her age at the time of his joining the post should neither be less than 18 years and not more than 45 years. Relaxation in upper age shall however be allowed in case of Scheduled Caste/Scheduled Tribe/OBC and Ex-Serviceman as per Rules.
3. His/ Her appointment will be subject to the production of Medical certificate of fitness from the Medical Officer of the Govt. Hospital.
4. The appointment shall further be subject to terms & conditions of accompanying form of Contract agreement / bond (Annexure-I) which is required to be executed between the candidate and HPSEBL (Appointing Authority) on stamp paper valuing Rs. 5/- only duly attested, by the competent authority.
5. He/ She should give a declaration that he has got only one living spouse or is a bachelor.
6. He/ She is required to produce antecedent verification certificate to the satisfaction of the Department from the Ist. Class Magistrate or two Gazetted Officers known to him/her at least for the last three years.
7. He/ She is required to produce his/her original Diploma/Degree from the recognized Institute and Matriculation certificate or equivalent thereof in proof of his/her requisite qualification and proof of age to the office concerned before joining the post.
8. He/ She is required to produce a certificate from the competent authority to the effect that he/she is bonafide resident of Himachal Pradesh, at the time of joining the post.
9. He/ She shall produce a certificate from the competent authority in support of his/her belonging to SC/ST/OBC/IRDP and Ex-Serviceman, in case he/she has been appointed against the vacancy reserved for these categories.
10. He/ She will be required to take oath/affirmation on the following form.

If the candidate(s) is ready and willing to accept the offer of appointment on contract basis on the terms and conditions given above, he/she should report for duty and execution of agreement at the station of his/her posting immediately with in 15 days from the date of issue of this offer failing which or in default whereof the offer shall automatically stand cancelled/withdrawn and the candidate will have no right to claim it and next candidate of waiting panel shall be appointed.
