1. He/- she will be paid consolidated monthly emoluments @ Rs.7175/- (indicate basic pay of initial; pay scale of the post) i.e. Rs.4900+1300 GP+75%GP. He /She shall not be entitled for any other allowance whatsoever to the employee of the State Govt. / Board from time to time.
2. The appointment shall be purely on contractual basis for a period of one year from the date of joining the post.
