In pursuance of the policy as notified by the Board vide office order No. HPSEBL (SECTT)/R&E/14-2(EAS)/2017-13138-358 dated 20-05-2017 with regard to providing compassionate assistance to the dependents of deceased Technical/Engineer employees of HPSEBL, who met with Fatal/Non fatal accident during their duty hours and as per the recommendation of the WTD's of HPSEB Ltd. for making the appointment for the post of **Junior Helper (PHE) & Junior T- Mate (Class-IV post)**, the approval is hereby conveyed for the appointment of following candidates as purely on contract basis under Employment Assistance Scheme against 5% posts of net vacancy in direct recruitment quota and in relaxation of ban on direct recruitment as per the clause-7 (a) & (b) of ibid scheme on **fixed monthly contractual amount** equal to minimum of the Pay Band plus Grade Pay of the post (i.e. Pay Band Rs. 4900-10680+1300Grade Pay+75% enhanced Grade Pay only) as per R&P Rules in relaxation of upper age limit in the cases whose age exceeding 30 years.

The appointing authorities are also directed to complete all the codel formalities to maintain the service records of each candidates, who joins the service in their respective office(s). The terms & conditions for contractual appointments shall be followed strictly as notified vide this office notification No.HPSEBL (SECTT)/ R&E/106-10/2006-86012-213 dated 07.12.07 and even file dated 28.02.13 / 11.12.14 and 01.07.15.

It will be the responsibility of each appointing authority to check/verify all the related documents/certificates of the above newly candidates during the time of his/their joining i.e. Caste/Academic/Technical qualification, if any/and Date of Birth certificates etc., as per R&P Regulations notified by the HPSEBL before accepting their joining and to ensure that other terms and conditions are fulfilled as per instructions. The Cadre-Controlling authority will maintain the category wise roster of the candidates at their own level.




